PROCEDURES FOR SHELTER-IN-PLACE / LOCKDOWN Describe your procedures (who, what, where, when)

All of the students with their teachers will go to the preschool room, if that room is not available, all students and staff will go to the toddler room, in the time of a shelter-in-place/lockdown emergency. Staff will cover all windows and lock all doors. The lead preschool teacher will call emergency responders and parents of all students. Our emergency kit is located in the prep-room and the lead toddler teacher will be in charge of getting it.

Each class will walk out the nearest door and walk safely across the street to the side walk in front of the Dundas post office or inside the post office, whichever is safest.

Infants/Non-walkers will be transported by cribs. Walkers will follow their teachers, and all walk together.

7. Identification of Hazards

Fire	Get all students and staff safely out of the center, call 911, notify parents, if center is damaged/in-need of inspection/repairs. CALL DHS AND REPORT A FIRE WITHIN 24 HOURS
Flood	Depending upon the situation, may need to close temporarily but will reopen ASAP.
Gas/Chemical Leaks	Immediate evacuation. Notify parents to pick-up students until leak is contained/fixed and/or repairs are made.
Hazardous Materials	Are kept out of reach of students, high up, locked, or in basement where students do not have access to.
High or Low Temperatures	Stay inside if extreme heat/cold
Infectious Diseases	Notify county along with ALL parents/guardians if there is a spread. Center may need to close for extra deep cleaning.
Nuclear Power Plant	Please note, there are two nuclear power plants in Minnesota. Depending on your proximity to these plants, which are located in Welch and Monticello, you may/may not have a potential "risk of harm." N/A
Severe Winter Weather	We follow the Northfield School District for the most part. In case of severe weather, we may need to close early or close for the day depending upon road conditions, etc.
	If severe, grab emergency kit. Stay in all classrooms and cover windows. Main hallway and ADA bathroom can also be used for shelter.
	Grab emergency kit. Go to the hallway or stay in all classrooms and cover windows. Main hallway and ADA bathroom can also be used for shelter. CALL DHS AND REPORT TORNADO WITHIN 24 HOURS
Violent Incidents	Call 911 and notify parents ASAP
Other	Grab emergency kit in case of evacuation
